FGBMFI-USA Job Description for Regional Director

<u>Purpose</u>: To represent and support the FGBMFI-USA, the USA National President, and the USA National Board in the defined region of responsibility; always remaining focused on the guidance of the Holy Spirit.

Specific Responsibilities:

- Promote growth within the designated region, by starting new chapters with anointed leaders (who are baptized in the Holy Spirit according to Acts 2:4), providing training (especially experiential), and motivating leaders and members (especially leading by example) to touch the lives of people for our Lord in accordance with the Great Commission and the Vision of our Fellowship. Fostering a culture of ongoing corporate and individual prayer which reinforces that the growth and strength of the Fellowship is reliant on the Holy Spirit.
- ➤ Sign acceptance of Chapter Charter Agreement for new chapters in region on behalf of FGBMFI-USA, after Chapter President and Secretary have signed Chapter Charter Agreement Form.
- Assign or replace Regional Coordinators, Area Coordinators, and/or Field Representatives to oversee a designated area and help bring expansion to the region.
- Encourage and motivate existing chapters (the backbone of the fellowship) and leaders in the region to stay in the vision and see it fulfilled via in-person visits, Zoom, phone calls, emails, and/or via appointed representative(s).
- Participate in weekly USA Leaders meetings via Zoom, annual USA Directors meeting, and the USA National Convention.
- Provide voice and vote (as a member of the National Board of Directors) on matters of national policy.
- Settle local disputes by the leading of the Holy Spirit, in accordance with the FGBMFI-USA Bylaws.
- ➤ Help coordinate, support, or oversee regional events such as Advances, School of the Vision, and Leadership Training.

- Encourage chapters to support FGBMFI-USA initiatives such as Voice Magazine, the USA National Convention, etc.
- Provide additional support as specifically requested by the National President or USA Board of Directors.

Qualifications for Regional Director:

- Is **born-again** having recognized Jesus Christ as Savior and Lord.
- Is baptized in the Holy Spirit according to Acts 2:4.
- Be a paid member of FGBMFI-USA.
- Be a member of a FGBMFI-USA chapter.
- Supports the manifestation of the Gifts of the Holy Spirit as listed in 1 Corinthians 12:4-11: Word of Wisdom / Word of Knowledge / Faith / Healing / Working of Miracles / Prophecy / Discerning of Spirits / Tongues and Interpretation of Tongues.
- Has read the books of Demos Shakarian:
