

## **FGBMFI-USA**

### **Job Description for Regional Field Representative**

**Purpose:** To represent and support the Regional Director in all geographical areas within the Director's defined region of responsibility; always remaining focused on the guidance of the Holy Spirit.

**Specific Responsibilities:**

- Help to strengthen vertical and horizontal communications in the region by visiting the chapters and building relationships with local officers and area coordinators (for e.g., feedback to Regional Director about common issues being experienced in chapters, sharing of best practices with Chapter Presidents, clarifying changes impacting treasurer or secretary functions/requirements, etc.).
- Provide feedback and support/training to Chapter Presidents regarding choice of speakers, quality of testimonies, managing meetings etc.
- Help ensure new chapters are properly trained and have the necessary administrative support from headquarters and are compliant with the constitution and by-laws as it applies at the chapter level. Note: It is also important to simultaneously help foster an environment which gives the Holy Spirit an unfettered ability to express a unique identity for each chapter.
- Explore/recommend opportunities for growth in different areas of the region by working with nearby Chapter Presidents and Area Coordinators.
- Encourage/equip Chapter Presidents to build positive relationships with area churches, ministries etc. to open opportunities to share the Baptism of the Holy Spirit; also, for them to encourage/equip their individual members to do the same in their places of worship/fellowship as the Spirit leads.
- Help coordinate regional events such as Advances, the School of the Vision, Leadership Training and encourage chapters to support FGBMFI–USA initiatives such as Voice Magazine, the National Convention etc.
- Provide additional support as specifically requested by the Regional Director.

### **Qualifications for Regional Field Representative:**

- Be a paid member of FGBMFI-USA.
- Be a member of a FGBMFI-USA chapter.
- Is Born-again having recognized Jesus Christ as his/her Savior.
- Is baptized in the Holy Spirit and speaks in tongues.
- Supports the manifestation of the Gifts of the Holy Spirit as listed in 1 Corinthians 12:4-11: Word of Wisdom / Word of Knowledge / Faith / Healing / Working of Miracles / Prophecy / Discerning of Spirits / Tongues and Interpretation of Tongues.
- Has read the books of Demos Shakarian:

  - The Ultimate Dimension
  - A New Wave of Revival in Your Finances
  - Divine Life
  - Behold the Glory of God
